## **Old Business:**

Flock Prefix

- (1) Ron moved to set a policy: "KHSI will not allow the reusing of any unique flock ID if a single animal had been registered with that ID." Robert second. Passed
- (2) Ron moved to set a policy: "If a KHSI member is in arrears for three or more consecutive years and the Flock ID assigned to them has never been assigned to a registered sheep by the said member, the Flock ID assigned to that membership will become available for use by new members. This policy will become effective January 1<sup>st</sup>, 2021." Michelle second. Passed
- (3) Ron moved to set a policy: "All members will have a unique Flock ID not to exceed the limit of space allowed by Associated Registry." John second. Passed
- (4) Michelle moved to set a policy: "All numeric digits in the Name of the animal on the Certificate of Registration (Also listed as the Private Flock Tag) must be on at least one of the animal's eartags." Ron second. Passed
