

MINUTES  
KHSI SPECIAL BOARD MEETING

October 8, 2025

President Cindy DeOrnellis called the meeting to order at 8:07 pm EST.

Present- Cindy DeOrnellis, Mike Jones, Brad Mullins, Mandy Fletcher, Ron Young, Dan Turner, Karen Kenagy and Operations Manager- Alan Culham.

Brad Mullins presented the January-September 2025 Profit/Loss for KHSI.

Income was \$27,397 less for the Registry .

Expenses were \$29,623 more for the Registry .

Totaling to \$56,020 less Net Profit for the January- September 2025, compared to the Net Profit in 2024 for the same time period.

This includes January-April 15, 2025 financials with Associated Registry , in which KHSI banked \$4.50 per Registration and Transfer. Making the Net Profit seem better than it actually was for January – September 2025. At the same time Registrations and Transfers have actually been higher than 2024.

President Cindy reported communicating with Associated Registry and asking them what they would offer KHSI .

Associated Registry Contract Offer

A) Member Online generated transactions -totally completed by member and prints certificate with no help. No charge to KHSI.

A fee will only be applied if assistance is required.

B) Print and Mail- registration, transfer, membership (No Assistance ) : Registration, Upgrades and Transfers at \$1.50 per transaction.  
Memberships @ \$1.50 per transaction.  
Reprint lost/damaged Registration Certificates @ \$1.50 per transaction.

C) Breeder submitted/Full service:

Registration, Upgrades, and Transfers at \$4.50 per transaction.

Memberships at \$4.50 per transaction.

Reprint lost/damaged Registration Certificates at \$4.50 per transaction.

Christening/Name change (reprinted Certificates w/name) at \$4.50 per transaction.

Rush Fee- \$10

All board members received a complete copy of the Associated Registry contract.

Ron Young moved that KHSI terminate Brenda Lobdell-Scheider's services as to processing registrations, transfers, memberships and all other transactions effective immediately (October 7,2025). Further, KHSI agree to terms with Associated Registry as per their contract offer. Making Associated Registry , KHSI's Registrar effective October 8,2025.
